The Board is pleased to announce that the English name of the Company has been changed from “Heng Sheng Holdings Limited” to “Shi Shi Services Limited” and the dual foreign name of the Company in Chinese has been changed from “恒生控股有限公司” to “時時服務有限公司”, both with effect from 18 September 2018. Accordingly, the logo of the Company has also been changed.

The stock short name of the Company for trading the Shares on the Stock Exchange will be changed from “HENGSHEG HLDGS” to “SHISHI SERVICES” in English and from “恒生控股有限公司” to “時時服務” in Chinese with effect from 9:00 a.m. on 31 October 2018.

Reference is made to the announcement of the Company dated 15 August 2018 and the circular of the Company dated 23 August 2018 (the “**Circular**”) and the poll results announcement of the Company dated 17 September 2018 in relation to, inter alia, the Change of Company Name. Unless otherwise stated, capitalised terms used herein shall have the same meanings as defined in the Circular.

## **CHANGE OF COMPANY NAME AND LOGO**

The Board is pleased to announce that, after the passing of a special resolution in relation to the Change of Company Name by the Shareholders at the EGM held on 17 September 2018, the Registrar of Companies in the Cayman Islands approved the registration of the new names of the Company and issued the Certificate of Incorporation on Change of Name on 18 September 2018. The conditions for the Change of Company Name have therefore been satisfied and the English name of the Company has been changed from “Heng Sheng Holdings Limited” to “Shi Shi Services Limited” and the dual foreign name of the Company in Chinese has been changed from “恒生控股有限公司” to “時時服務有限公司”, both with effect from 18 September 2018. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 October 2018 confirming the registration of the new names of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) with effect from 16 October 2018.

Accordingly, the logo of the Company has also been changed from “” to “” with immediate effect.

## **CHANGE OF STOCK SHORT NAMES**

Following the Change of Company Name becoming effective, the stock short names of the Company for trading the Shares on the Stock Exchange will be changed from “HENGSHENG HLDGS” to “SHISHI SERVICES” in English and from “恒生控股有限公司” to “時時服務” in Chinese with effect from 9:00 a.m. on 31 October 2018.

## **EFFECT OF THE CHANGE OF COMPANY NAME**

The Change of Company Name will not affect any rights of the Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company will continue to be good evidence of legal title to the Shares and will remain valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for free exchange of existing share certificates of the Company for new share certificates bearing the new names of the Company. New share certificates of the Company will be issued under the new names of the Company. The stock code of the Company on the Stock Exchange will remain unchanged as “8181”.
